## Fixed Rate Branch Bond

#### What is the interest rate?

Interest is calculated daily on funds once they have been paid into the Fixed Rate Branch Bond during the funding window. We'll pay the interest on the anniversary of the date you opened your account (regardless of when the account was funded), at the end of the term, and on the day your account closes.

## Can Nationwide change the interest rate?

No. The interest rate is fixed, so we can't change it during the term.

# What would the estimated balance be at the end of the fixed term based on a £1,000 deposit?

If you fund your account on the date of opening:

The table above shows what a future balance might look like. It assumes that you keep your account and the money in it until the end of the term.

## How do I open and manage my account?

#### 1. Check you can have this account

You need to:

• be a UK resident aged 16 or over

You can open the account with a minimum of £1 up to a maximum of £5 million.

You cannot open this account in trust for the benefit of another person.

**Please note:** You have 14 days to pay money into your account from the date it's opened. Just so you know, when you pay in from another bank or building society, it may take up to 24 hours from opening the account before they can find your new account details.

Interest will only start to be paid from the day we receive funds into the account, so it's a good idea to pay money into the account as soon as you can. For example, if you don't pay money into your account until day 14 you'll only get interest for 351 days, rather than 365 days.

## Can I withdraw money?

Once the account is open, there is a 14 day cancellation period where you will be able to cancel your Fixed Rate Branch Bond and your money will be returned to you.

During the term, you can't take any money out of your account.

#### At the end of the term

At the end of the term, your Fixed Rate Branch Bond will mature into an instant access savings account. We'll contact you before your Fixed Rate Branch Bond matures with more information.

### **Additional information**

#### Interest rate terms explained

- AER: Stands for Annual Equivalent Rate and illustrates what the interest rate would be if interest was paid and compounded once each year.
- Gross a year is the interest rate without tax deducted.
- Funding window is 14 days from the day that the account is opened, which you will be able to add money into the account.

The treatment of your account for tax purposes will depend on your individual circumstances and you may need to pay tax on any interest that exceeds your Personal Savings Allowance.
